## HB735 by Representative Beryl Amedee

CONSUMERS/PROTECTION: Provides relative to indemnified products

Current Status: Pending House Commerce



## HB253 by Representative Kathy Edmonston

DISCRIMINATION: Prohibits discriminatory practices on the basis of vaccination status or immunity status

Current Status: Pending House Civil Law and Procedure



## HB573 by Representative Danny McCormick

HEALTH/LDH: Provides for the prohibition of marketing to minors for medical products, procedures, and pharmaceuticals from state agencies

Current Status: Pending House Health and Welfare



## HB12 by Representative Larry Frieman

LEGISLATIVE POWERS: Provides relative to termination of emergency declarations

Current Status: Pending House and Governmental Affairs



## HB47 by Representative Kathy Edmonston

VACCINES/VACCINATION: Requires that any communication issued to students or parents relative to immunization requirements include exemption information and an exemption form

## HHB54 by Representative Larry Bagley

CRIME/MISDEMEANOR: Creates the crime of discrimination based on vaccination status (OR INCREASE LF EX See Note)

## HB117 by Representative Michael Echols

DRUGS/PRESCRIPTION: Provides relative to prescribing, administering, and dispensing of drugs for off-label use

## HB126 by Representative Troy D. Romero

UNEMPLOYMENT COMP: Provides for unemployment compensation benefits to claimants terminated as a result of vaccination status

## HB427 by Representative Beryl Amedee

VACCINES/VACCINATION: Prohibits the administration of vaccines to minors on school property and at school-sponsored events

## HB479 by Representative Larry Frieman

HEALTH/MEDICAL TREATMENT: Provides relative to a patient's rights to certain medical treatments

## HB531 by Representative Beryl Amedee

VACCINES/VACCINATION: Provides for civil remedies for a student who is denied entry into school because of immunization requirements

## HB535 by Representative Beryl Amedee

INSURANCE/HEALTH: Prohibits group health plan and life insurance policy issuers from denying coverage or offering incentives based upon vaccination status

## HB594 by Representative Beryl Amedee

HEALTH CARE: Provides for rights of individuals to bodily autonomy and to make healthcare decisions

## HB640 by Representative Mark Wright

VACCINES/VACCINATION: Provides relative to vaccines and vaccine-related pharmaceuticals produced with aborted human fetal-derived cells or human embryonic-derived cells

## SB29 by Senator Stewart Cathey, Jr.

HEALTH CARE: Prohibits discrimination against healthcare professionals and provides for protection of healthcare professional credentials.

## SB92 by Senator Stewart Cathey, Jr.

DISCRIMINATION: Prohibits employers from discriminating against employees due to their medical history. (8/1/22)

## HCR3 by Representative Larry Bagley

VACCINES/VACCINATION: Repeals administrative rules of the La. Department of Health adding COVID vaccines to the state immunization schedule and requiring schools to prohibit in-person attendance by certain unvaccinated students

## HB53 by Representative Larry Frieman

HEALTH: (Constitutional Amendment) Provides with respect to autonomy in making personal health care decisions

## HB177 by Representative Kathy Edmonston

DISCRIMINATION: (Constitutional Amendment) Prohibits discrimination based on vaccination or immunity status

HEALTH CARE: (Constitutional Amendment) Provides for rights of individuals to bodily autonomy and to make healthcare decisions

# Key Legislation



## HB232 by Representative Kathy Edmonston

MTR VEHICLE/DRIVER LIC: Prohibits requiring vaccination verification or immunity status for certain transactions or for inclusion on a driver's license or special identification card

Current Status: Pending House Transportation, Highways, and Public Works

## HB354 by Representative Valarie Hodges

PUBLIC HEALTH: Prohibits local governmental subdivisions from requiring proof of medical status as a condition of participating in a constitutionally protected activity

## HB407 by Representative Beryl Amedee

VACCINES/VACCINATION: Prohibits adding any vaccine with emergency use authorization status to the list of vaccinations required for school and child daycare entry

Current Status: Pending House Health and Welfare

## HB428 by Representative Beryl Amedee

EDUCATION: Prohibits the State Board of Elementary and Secondary Education and the state Department of Education from recommending any vaccine or medical procedure

Current Status: Pending House Education

## SB37 by Senator Michael "Big Mike" Fesi

HEALTH CARE: Prohibits denial of healthcare services based on vaccination status. (8/1/22)

## SB58 by Senator Michael "Big Mike" Fesi

HEALTH CARE: Provides relative to privacy of immunization status. (8/1/22)

Current Status: Pending Senate Health and Welfare

## SB141 by Senator Jay Morris

INSURANCE POLICIES: Prohibits insurance companies from requiring a person or business to have a certain vaccination status or requiring information from an applicant or policyholder regarding vaccination status. (8/1/22)

LIABILITY: Provides relative to public health emergencies. (gov sig)
