

DID YOU KNOW?

- 1** Vaccine manufacturers **CANNOT BE SUED**.
 - ▲ In 1986 Congress - under pressure from vaccine manufacturers because of numerous lawsuits over the DTP vaccine¹ - passed the National Childhood Vaccine Injury Act (NCVIA) which removed all liability from vaccine manufacturers. Vaccines are the **ONLY** consumer product where manufacturers are not held responsible for harm or death.
- 2** Since the passage of NCVIA the number of vaccines given from pregnancy to eighteen years has increased **EXPONENTIALLY** - almost **FOUR TIMES** - from **24 doses of 7 vaccines for 7 diseases in 1983 to now 81 doses of 15 vaccines for 18 diseases**.²
- 3** The effects of receiving the cumulative number of vaccines on the CDC's recommended schedule have **NEVER BEEN STUDIED**. Furthermore, **NO ADEQUATE VACCINE SAFETY STUDIES EXIST**.
 - ▲ There are **ZERO** vaccine safety studies that use a saline/inert placebo. Instead, another vaccine or adjuvant is used as the "placebo".³
 - ▲ There are **ZERO** studies examining key elements of the entire schedule—the number, frequency, timing, order, and age at administration of vaccines.⁴
 - ▲ There are **ZERO** long-term vaccine safety trials. Some are as short as **3 DAYS**.⁵
 - ▲ Vaccine safety studies **do not test for carcinogenicity** (causes cancer), **mutagenicity** (causes mutations in dna), or effects on male or female **fertility**, as noted on Section 13.1 of each manufacturer's package insert.
 - ▲ The U.S. childhood immunization schedule has more vaccines than any other country in the world, yet among comparable wealthy nations it has the **highest infant mortality rate**⁶ and the sickest children—**54% of U.S. children have a chronic illness and/or developmental disability**.⁷
- 4** The U.S. Department of Health & Human Services (HHS) **HAS NOT CONDUCTED SAFETY TESTING** as legally required by NCVIA. In July 2018, only after a lawsuit was filed, HHS admitted to **never submitting a single report** to Congress.⁸
- 5** As of November 1, 2019, the Vaccine Injury Compensation Program (VICP) has paid out **\$4.7 BILLION**⁹ to petitioners alone (not including attorney fees).
- 6** Vaccines contain **neurotoxic, carcinogenic, and never-proven-safe ingredients**¹⁰ including: aluminum adjuvants, aborted fetal cells, formaldehyde, polysorbate 80, animal DNA (monkey & dog kidney cells, chick embryo cells, blood from pigs and other animals), thimerosal, and more.
 - ▲ **More than 85 babies from elective abortions**¹¹ have been used in the manufacturing of vaccines.
 - ▲ Aborted babies are still being used for vaccine research. In 2015 a **new human cell line, Walvax-2, was derived from the lung tissue of an aborted 3 month female fetus**. It took **9 aborted fetuses** to develop.¹²
- 7** Many Louisiana schools **UNLAWFULLY DISCRIMINATE** against children who aren't considered up-to-date on their vaccines.
 - ▲ According to Revised Statute 17:170 Section E,¹³ parents can claim an exemption to vaccine requirements.
 - ▲ The law applies to **public AND private daycares/schools** (whether or not they accept state funding).
- 8** Scientists have made several breakthroughs and groundbreaking discoveries in the past few years.
 - ▲ New research provides scientific proof and an undeniable clear picture of how **VACCINES CAN CAUSE AUTISM**.¹⁴
 - ▲ In 2018 Dr. Andrew Zimmerman's deposition in the Yates Hazlehurst case revealed the Department of Justice attorneys **committed fraud** in the Omnibus Autism Proceeding of 2009.¹⁵ The DOJ attorneys barred Dr. Zimmerman from testifying as a witness yet they submitted his written testimony while deliberately omitting any mention of his belief that vaccines could be a direct cause of autism. Their omission led to the dismissal of thousands of families' claims comprising more than 5,500 children with autism.
